

Dear Returning Hotchkiss Parents,

The Health Center staff requests your assistance in completing the required health forms for the 2019-2020 school year.

All forms are due by July 15th.

<u>Copy of Front and Back of Health Insurance Card</u>, including name and date of birth of policy subscriber. This is required if you are not electing United Healthcare Student Resources coverage through the business office.

Returning Student Health Form: This form is required. Please include any injuries, illnesses, vaccinations, or changes in your student's medications or health status. An annual physical is recommended, but not required. If your student is examined by his or her health care provider, please have the provider complete the bottom portion of the form.

<u>Permission to Administer Medication</u>: This form is REQUIRED ANNUALLY for all students who will be taking prescription medications while on campus. Please note both a prescriber and parent signature are required on the form for the Health Center to dispense medication. All prescription medications must be in original pharmacy packaging and clearly labeled with your child's name, medication, and dosage.

Salisbury Pharmacy Registration: For compliance with safety standards, all medication that is required to be stored in the Health Center, including, but not limited to controlled narcotics, stimulant medications, and psychotropic medications, must be in pre-packaged individual dose packets as Health Center staff are not permitted to repackage medication. The Salisbury Pharmacy provides Medicine on Time, individual dose packaging, and delivers medications to campus on a daily basis, Monday through Friday. Families must register with the pharmacy at http://schools.spgrx.com for prescriptions to be filled and pharmacy staff can also be reached at 860-435-9388 with any questions. We strongly encourage you to establish an account with the pharmacy. In the event your child needs medication it expedites the process if the account is in place.

<u>Influenza (Flu) Vaccine Consent:</u> We strongly encourage all students to receive the flu vaccine annually. If you need additional information, please visit http://www.cdc.gov/flu/.

These forms are accessed through Medicat, the electronic medical record system used by the Health Center.

Click on https://hotchkiss.medicatconnect.com/login.aspx to go to the Medicat Parent Portal.

- 1. If you have not previously registered, Medicat's site will provide you with directions to register and login.
- 2. If you have more than one child at the school, you will have the option to select one of your children.
- 3. Under the "Forms" tab, all downloadable forms are available to print and complete.
- 4. Completed forms can be uploaded directly into the Medicat system under the "Upload" tab.
